DWS Concept Platow – December 2023 Report

Large caps lead, small caps lag. Those stark words describing the past year on the stock market are not an overstatement. Although "small" actually refers to micro-cap stocks, stocks whose market cap falls below the threshold for inclusion in the SDAX. Many of these tiny stocks did not even show a positive return for the past year. The Scale All Share Index, for example, closed 2023 in the red.

That is all the more surprising considering that the widely recognized DAX index shined bright in 2023 and delivered a clearly better-than-average performance. The mid-cap stocks

tracked by the MDAX had less swagger but they still showed a very pleasing performance, about the same as that of the DWS Concept Platow. Although the fund's absolute return was solid, and not far below the fund's average annual return since it was launched in 2006, we are not satisfied with its performance in 2023. This is because the SDAX, the index that has traditionally been

the most comparable with the fund's portfolio, made a much better gain in 2023. The fund has still clearly outperformed this small-cap index since inception, but its large lead has shrunk.

The general focus on the strong year-on-year performance of the DAX, the index that attracts the most media coverage, obscures the challenges that stock pickers faced in 2023, especially in the small cap segment. We can illustrate this with the following two proportions: Only about one of every four stocks in the SDAX was able to beat the total SDAX return, which is an exceptionally low proportion in historical terms, and, despite the strong index performance, about one of every two SDAX stocks ended the year with a negative return! This abnormal performance dispersion made it quite difficult to pick a reasonable number of winning stocks.

In 2023, the top performers in the DWS Concept Platow portfolio were Gerresheimer, Talanx, Kontron and Bechtle, most of which, we're pleased to say, are core positions (see table in the left column). The biggest losers that were still in the portfolio at the end of 2023 were Verbio, BayWa, Ringmetall and Hawesko, all of which are small positions, and we had significantly reduced their weightings during the course of 2023. CropEnergies developed the strongest life of its own of all the portfolio stocks: After its near-continual retreat since the beginning of the year, Südzucker, the parent company of CropEnergies, issued a takeover bid that abruptly reversed the down trend and made CropEnergies the portfolio's best performer by far in December. Speaking of December returns, not a single stock in the portfolio showed a double-digit percentage loss in the final month of the year, which has rarely been the case since the fund's inception.

Is this the calm before the storm? Or are equity investors expecting 2024 to be another year with positive returns? We don't know, but questions like these play no more than a minor role in our investment strategy. We do not try to "time" the market. Instead we focus on selecting individual stocks using our proven investment approach, which is guided by fundamental research and other data, rounded out with technical and non-quantitative inputs. We know that this approach will not function perfectly every calendar year and that awareness is embedded into our long-term strategy. From this angle, then, last year's decent but not stellar return for fund investors doesn't make us uneasy.
